- **Data Privacy and Protection:** BharatCares shall ensure compliance with data protection norms and use student data only for onboarding, tracking, and impact assessment.
- **Consent:** The Institution consents to BharatCares capturing photographs, testimonials, and impact stories during workshops or sessions for social media and program reporting purposes, ensuring all usage is ethical and respectful.
- **Limitation of Liability:** The Institution will be responsible for mobilizing learners and supporting program delivery, while BharatCares shall manage all content and facilitation.
- **Financials:** This LoU is non-financial in nature, involving no monetary transaction between the parties. BharatCares will bear all costs related to facilitation, mentorship, and reporting.
- **Communication and Reporting:** BharatCares shall provide timely reports and updates to the Institution to monitor participation, learning outcomes, and impact metrics.
- **Legal Aspects:** This LoU represents a statement of intent and does not create any legally enforceable or financial obligations between the parties.
